In exercise of the powers conferred upon me by section 65K (1) of the Representation of the People Act, I hereby appoint 28th September, 1992 as the day on which members of the disciplined forces, specified by the Elections Commission by order dated 14th September, 1992 and entitled to ballot under Part VIIB of that Act, may Ballot.
