IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE PUBLIC CORPORATIONS ACT 1988, AS APPLIED TO GUYANA STOCKFEEDS LIMITED BY NOTIFICATION UNDER SECTION 66 OF THAT ACT, I HEREBY MAKE THE FOLLOWING ORDER.

1. This Order may be cited as the Guyana Stockfeeds Limited. (Transfer of Property) Order 1992 and shall be deemed to have come into operation on 17th September, 1992.

2. In this Order —

Interpretation.

- (a) "Agreement" means the Agreement made on the 1st September, 1992 between the Company and the Purchaser;
- (b) "appointed day" means the day on which this Order is deemed to have come into operation;
- (c) "Company" means the Guyana Stockfeeds Limited, being a company incorporated under the Companies Act, Cap. 89:01, and whose office is situated at Farm, East Bank Demerara, Guyana;
- (d) "Property" means the property described in the Schedule, being property belonging to the Company;
- (e) "Purchaser" means Mr. Ivan Crandon, of Perseverance, West Mahaicony, East Coast Demerara, Guyana.

3. Pursuant to the Agreement and subject to the terms and conditions specified therein, the Property is hereby transferred, with effect from the appointed day, to Belmont Investments Limited, being a Company incorporated by the Purchaser under the Companies Act, Cap. 89:01, and whose office is situated at Perseverance, West Mahaicony, East Coast Demerara, Guyana, being a company specified in this behalf by the Purchaser under paragraph 7 of the Agreement.

All that Block lettered "B" containing 1.843 (one decimal eight four three) acres and being part of lots number 1 (one) and 2 (two) Belmont, in the West Mahaicony Village, District, situate on the east sea coast of the County of Demerara, in the Republic of Guyana, the said lots numbered 1 (one) and 2 (two) being laid down and defined on a plan by William Downer, Sworn Land Surveyor, dated 21st December, 1848 and deposited in the Deeds Registry at Georgetown, 27th December, 1848, with the building and erections thereon, and the said block "B" situated on the southern side of the Public Road is laid down and defined on a plan by John E. Davis, Sworn Land Surveyor, dated 29th June, 1978, and deposited in the Deeds Registry at Georgetown on the 30th day of November, 1978, save and except a piece of land being part of the northern portion of the said lots numbered 1 (one) and 2 (two) measuring 90 (ninety) feet by 50 (fifty) feet with the Church building thereon, the property of the Presbytery of Guyana, the property herein described having been transported to the Company on 8th August, 1979 by Transport No. 1368/79.
