1.. This order, which amends the Consumption Tax Order*, may be cited as the Consumption Tax (Amendment) Order 1998 and shall come into operation on the 1st. of September ,1998.

Schedule. 2. During the continuance in force of this order, tax is payable on Vehicles four the goods specified in the Schedule (being motor vehicles years old and whose date of manufacture is four years or in excess of four years before the date of importation of such vehicles) at the respective rate so specified.

Schedule. 3. In respect of the goods mentioned in the Schedule to this order Amendment of that are also mentioned in the Schedule to the Principal Order, the Principal as amended by order no.9 of 1994, the tax payable thereon **Order:** vehicles shall remain the same but shall relate only to vehicles, the date less than four of manufacture of which is less than four years before the date vears old. of importation of such vehicles.
