## ORDER

## THE TRADE ACT

(Cap. 91:01)

IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:-

- Citation                    1.     This Order may be cited as the Trade (Control of Prices) (Matches) Order 1980 (No. 3) and shall be read and construed as one with the Trade Control of Prices Order.\*
- Inter-pretation.            2.     In this Order:-  
    (a)    "manufacturer" means any person who manufactures matches;  
    (b)    "distributor" means a wholesaler who purchases matches from a manufacturer for the purposes of resale.
- Maximum wholesale prices. Schedule.                    3.     The maximum prices at which the article described in the first column of Part A of the Schedule shall be sold by wholesale by a manufacturer, a distributor or a wholesaler, shall be as set out as manufacturer's price, distributor's price or wholesaler's price as the case may be in the second, third and fourth columns of the said Part.
- Maximum retail prices. Schedule                                4.     The maximum prices at which the article described in the first column of Part B of the Schedule shall be sold by retail, shall be as set out in the second, third and fourth columns of the said Part.
- Amendment of the Trade (Control of Prices) Order.                    5.     The Trade (Control of Prices) Order is hereby amended by the deletion from the Second Schedule thereto of the particulars in the first, second, third, fourth, fifth and sixth columns, respectively and the marginal note in relation to the article numbered 2 (Matches).
