IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY ORDER AS FOLLOWS:—

1. This order which amends the Trade (Control of Prices) (Non-alcoholic Aerated and Mineral Waters) Order* may be cited as the Trade (Control of Prices) (Non-alcoholic Aerated and Mineral Waters) (Amendment) (No. 5) Order 1980. Citation.
