THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT (Cap. 62:05)

WHEREAS by the Acquisition of Lands for Public Purposes (Wismar/Linden Housing Project) Order, 1980* made on the 29th February, 1980, the proposed establishment of a Housing Project on the land described in the schedule to that Order was declared to be a public work in accordance with section 3 of the Acquisition of Lands for Public Purposes Act;

AND WHEREAS by the said Order the Chief Works Officer together with his agents, servants or workmen was authorised under section 4 of the said Act to enter upon the said land for the purpose of surveying or otherwise examining such land with a view to the Acquisition of the whole or part thereof for the public work aforesaid;

AND WHEREAS, in accordance with the provisions of section 6 of the Act, the report of the Chief Works Officer and a plan of the land to be acquired have been laid before the Minister:

NOW THEREFORE, in accordance with the provisions of the said section 6, it is hereby declared that the land described in the schedule to this Order is required for the public work aforesaid.

This Order may be cited as the Acquisition of Lands for Public Purposes (Wismar/Linden Housing Project) (No. 2) Order, 1980.

SCHEDULE

- (1) A block of land (shown bordered red on plan) and shown laid down and defined on a plan by S.S.M. Insanally, Sworn Land Surveyor, dated 18th September, 1948 on record in the Department of Lands and Surveys as plan No. 5329, save and except the following:— Lot 1, Lot a, Lots 1-11, Lot 13, Lots 22-25, Lot 36, Lots 42-47, Lots 57-58, Lots 60-64, W ½ Lot 65, E½ Lot 66, Lots 69-73, Lots 82 & 83, Lots 87-103, piece of land 0.10328 Ac., and piece of land 0.04073 Ac.
- (2) Block "N" (shown bordered blue on plan) subdivided into Lots 1-37 and shown laid down and defined on a plan by J. Phang, Sworn Land Surveyor, dated 3rd October, 1955 on record in the Department of Lands and Surveys as plan No. 7173;
- (3) Block "R" (shown bordered yellow on plan) subdivided into Lots 136-188 and shown laid down and defined on a plan by R. M. Wong, Sworn Land Surveryor, dated 26th September, 1959 on record in the Department of Lands and Surveys without the buildings and erections thereon.

The above described Blocks of land being portions of the first, second and third depths of Lots 1-6 Section "B" and the first depth of Lots 7, 8 and 9 Section "B" Wismar on the left Bank of the Demerara River, in the County of Demerara are shown on a compiled plan by Bishun Dial, Sworn Land Surveyor, dated 30th July, 1980 and recorded on 20th September, 1980 in the Department of Lands and Surveys, Georgetown, as Plan No. 19095.
