Short title.

1. This Ordinance may be cited as the Young Men's Christian Association (Colony Trustees Incorporation) Ordinance.

Definition.

2. In this Ordinance—

“the Council” means the British Guiana Young Men's Christian Association Advisory Council.

Incorporation of trustees.

3. (i) Sir Alfred Parker Sherlock, Cecil Farrar, Robert Dickson Pringle, Charles Wheating, Arthur Piercy Gardiner Austin, John Edwin Strickland, and William George Smellie, and their duly appointed successors as trustees of the Council, shall be and are hereby created a body corporate by the name of the Incorporated Trustees of the British Guiana Young Men's Christian Association Advisory Council, and by that name shall have perpetual succession and may sue and be sued in all courts of justice in the Colony.

(2) The trustees shall have and use a common seal, which shall be used in the presence of at least three trustees, and the seal may from time to time be changed, but no change shall be made except by a resolution of the members of the Council convened for the purpose.

Their duties.

4. The trustees or their duly appointed successors of the Council shall at all times act and carry out their duties in accordance with the rules and instructions to trustees adopted at a meeting of the Council held on the 28th August, 1925, or at any other subsequent meeting or meetings; and any trustee or trustees may at any time be removed from office and his successor or successors be appointed by the Council.

Their removal.

Their acquisition of property.

5. The trustees shall have full power to acquire by purchase, transfer, donation, exchange, devise, bequest, grant, gift, conveyance, or otherwise, any movable and immovable property in the Colony, or any estate or interest therein.

Property to vest in trustees.

6. All movable and immovable property—

(a) possessed by the British Guiana Young Men's Christian Association; or

(b) acquired by, or which may hereafter be acquired by, the trustees under section 5 of this Ordinance;

shall vest in the trustees and shall be held by the said trustees for the benefit of the British Guiana Young Men's Christian Association.

Their disposal of property.

7. The trustees shall be entitled to sell, mortgage, lease, or otherwise dispose of and deal with all property for the time being vested in or acquired by them.

Change in their body.

8. No change of the trustees shall affect any movable and immovable property or any interest therein for the time being vested in them, but that property or any estate or interest therein shall vest in the succeeding persons from time to time appointed trustees by the Council in the same way and to the same extent that they were vested in the former trustees.

Saving.

9. Nothing in this Ordinance shall prejudice or affect the rights of Her Majesty the Queen, her heirs and successors, or any body politic or corporate, or any other person or persons except as mentioned in this Ordinance.
