OFFICIAL DESIGNATIONS.

11 of 1938. **An Ordinance to provide for a change in certain Official Designations.**

[25TH JUNE, 1938.]

Short title. **1.** This Ordinance may be cited as the Official Designations Ordinance.

Change of designations. **2.** On and after a date to be fixed by the Governor by notice in the Gazette the existing designations of the officers set out in the first column of the schedule to this Ordinance shall be changed to the designations set out opposite thereto in the second column of the said schedule, and the Governor may fix different dates in respect of the different offices therein set out.

Substitution of new designations for old in existing laws. **3.** Whenever in any Ordinance, regulation, rule, by-law or other instrument or document whatsoever, the designation or name of office mentioned in the first column of the said schedule is used, there shall be substituted with effect from any date fixed in accordance with the provisions of the last preceding section for such designation or name of office the designation or name of office mentioned opposite thereto in the second column of the said schedule.

Power of Governor in Council to add to schedule. **4.** The Governor in Council may by order at any time add to or amend the schedule to this Ordinance and the provisions of the last preceding section shall take effect with respect to any such order from a date fixed by the Governor by notice in the Gazette.
