THE MARITIME BOUNDARIES ACT 1977

(No. 10 of 1977)

- IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 41 OF THE MARITIME BOUNDARIES ACT 1977 THE FOLLOWING REGULATIONS ARE HEREBY MADE —
- 1. These Regulations, which amend the Maritime Boundaries (Fishery Zone Foes) Regulations 1977 may be cited as the Maritime Boundaries (Fishery Zone Fees) (Amendment) Regulations 1977.
- 2. Regulation 3 of the Principal Regulations is hereby amended in the following respects
 - by the substitution of the words "Subject to regulation 5 there"; for the word "There", and
 - (b) the substitution of the word "Agricultural" for the word "Agriculture";
- 3. Regulation 4 of the Principal Regulations is hereby amended by the substitution of the word "Agricultural" for the word "Agriculture".
- 4. The Principal Regulations are hereby amended in the following respects
 - (a) by the deletion of all the provisions thereof appearing after Regulation 4;
 - (b) by the insertion immediately after Regulation 4 of the following as Regulations 5 and 0 —
- "5.11) There may be made by an owner arrangements satisfactory to the Chief Agricultural Officer for the payment by way of instalments of any fee payable under Regulation 3.

- (2) Where such arrangements have been made under paragraph (1) the Chief Agricultural Officer shall in so far as practicable give effect to the provisions of Regulation 4 and in addition thereto indicate in writing —
 - (a) the balance of any fee outstanding; and
 - (b) the manner in which such balance shall be paid.
- (3) It shall be a term of any arrangements made with the Chief Agricultural Officer pursuant to paragraph (1) for the payment of any fee that failure to pay any instalment thereof as arranged renders the outstanding balance of such fee due and payable.
- 6. Any owner of a fishing boat who falls to make payment of the fee payable by him under regulation 3 or any part thereof in accordance with any arrangements made under regulation 5 shall be liable on summary conviction to a fine of ten thousand dollars and to imprisonment for six months."; and
 - (c) by the insertion immediately after Regulation 6 of the following Schedule as the Schedule to the Principal Regulations —

1.	Any fishing boat operating in the fishery zone but not doing so from a base in Guyana.	\$100,000
2.	Any foreign owned fishing boat exceed- ing 100 feet in length operating in the fishery zone from a base in Guyana.	\$ 50,000
3.	Any foreign owned fishing boat less than 100 feet in length operating in the ery zone from a base in Guyana.	\$ 12,500
4.	Any Guyanese owned fishing boat ex- ceeding 100 feet in length operating in the fishery zone from a base in Guyana.	\$ 5,000
5.	Any Guyanese owned fishing boat less than 100 feet in length operating in the fishery zone from a base in Guyana.	s 2,500°
