THE CUSTOMS ACT

(Cap. 82:01)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 15(8) OF THE CUSTOMS ACT, I HEREBY MAKE THE FOLLOWING REGULATIONS:—

1. These Regulations may be cited as the Caribbean Community Regulations 1982 and shall be deemed to have come into operation on 1st June, 1981. Citation.

9. The Fourth Schedule to the Act is hereby amended in the following respects — Amendment
of the
Fourth
Schedule
to the
Act.

(i) in Part 1 —

- (a) in regulation 1, insert the word "section" before the words "15(1)" where they occur for the second time;
- (b) delete regulation 2 (3) (j);
- (c) in regulation 5, substitute the word "Community" for the word "Preferential";
- (d) in regulation 6(2), substitute the words "2(3) (f)" for the words "3(3) (f)";
- (e) in regulation 8(1), insert the words "regulation 2(1) (b) (i) or" before the word "Appendices";
- (f) in regulation 8(3) (a) (ii), substitute the words "water of" for the words "water or";
- (g) in regulation 8(3) (e), insert the words "within the Community" after the word "manufactured";
- (h) delete regulation 11(3);

(ii) in Appendix A to Part 1

- (a) insert in the respective columns after Tariff Heading Number ex 21.05 the particulars specified in the respective columns of Schedule A to these regulations;
- (b) in the fourth column in respect of Tariff Heading Numbers 17.04, 20.03, 20.04; 20.05; ex 20.06 ex 20.07, 39.01; 39.02; 39.03; 39.04; 39.05; 39.06; 39.07 and ex 73.13 add the words "and subject to the provisions of Part II of the regulations of the Fourth Schedule" after the word "product";
- (c) in the third column in respect of Tariff Heading Numbers ex 21.05 and ex 50.09 insert the words "export price of the" before the word "finished";

(iii) in Appendix B to Part 1

- (a) in column 6, in respect of Tariff Heading Number Chapter 39 substitute the words "1st June, 1985" for the words "1st January, 1983";
- (b) in column 4, in respect of Tariff Heading Number ex 48.15 substitute the words "1st June, 1982" for the words "1st January, 1980";
- (c) in column 6, in respect of Tariff Heading Number ex 48.15 substitute the words "1st June, 1985" for the words "1st January, 1983";
- (d) in column 6, in respect of Tariff Heading Number ex 62.02 substitute the words "1st June, 1985" for the words "1st January, 1983";
- (e) in column 4, in respect of Tariff Heading Number ex 73.13 substitute the words "1st June, 1981" for the words "1st January, 1979";
- (f) in column 6, in respect of Tariff Heading Number ex 73.13 substitute the words "1st June, 1985" for the words "1st January, 1983";

(g) in columns 4 and 6, substitute the words "1st June, 1983" for the words "1st January, 1981" wherever they occur; and

(iv) in Appendix C to Part 1

insert the respective columns after Tariff Heading Number 93.07 the particulars specified in the respective columns of Schedule B to these regulations.
