**1. Publication**

AN ACT to amend the Court of Appeal Act to provide for appeals by the Director of Public Prosecutions to the Court of Appeal and the Caribbean Court of Justice and for connected matters. The Bill was published on 11<sup>th</sup> July, 2008.

**2. Introduction, First and Second Readings**

The Bill was introduced in the National Assembly and read for the first time on 17<sup>th</sup> July, 2008.

It was debated and read a second time on 24<sup>th</sup> July, 2008.

**3. Committal to Select Committee**

Following its second reading, the Bill was committed by the National Assembly to a Special Select Committee for consideration.

**5. First meeting of the Committee - Election of Chairman**

At its first meeting held on 22<sup>nd</sup> December, 2008 the Committee elected the Hon. Doodnauth Singh, S.C., M.P., Minister of Legal Affairs, as Chairman of the Special Select Committee.

On 15<sup>th</sup> October, 2009, the Special Select Committee met and elected the Hon. Charles R. Ramson, S.C., M.P., Attorney General and Minister of Legal Affairs, as Chairman of the Committee.

1. The Director of Public Prosecutions should have the right to appeal due to the fact that many no case submissions were upheld when there was evidence which should have gone to a jury.
2. The quashing of indictments by High Court Judges.
3. The Director of Public Prosecutions should be able to appeal against misdirections by the trial judge.
4. Proposed amendments to Section 34H, 34J (2) and 34J (4) of the Bill.
5. Limitations of the Director of Public Prosecutions with regards to the injustices meted out to the relatives of victims.
6. Adequate time allotted for the Director of Public Prosecutions to appeal against acquittals.
7. Imbalance in the judicial system.

7.2.3 At 3.30 p.m. the Director of Public Prosecutions concluded her presentation and the Chairman invited Members to proceed with their questions, observations and issues for clarification.

7.2.4 The following were some of the issues highlighted:

1. The Director of Public Prosecutions with regards to defendants not being given a speedy trial. It was the view that it was the duty of the state to expedite cases.
2. The Jury trial should be left intact whether there was a presumed misdirection of the jury or not.
3. Regardless of the charge, there should be no discretion of bail for an individual, should the Director of Public Prosecutions seek to appeal an acquittal.
4. Whether any amendment to the legislation could possibly undermine the jury trial?
5. Attrition rate at the Director of Public Prosecution's Chambers.
6. Improvement in the quality of prosecutors.
7. The need for proper investigative capacity.



6.1.1 In response to a question asked, the Chairman informed Members that the Committee was not in receipt of any submission from the Judiciary. He, further stated that the Chancellor had verbally informed the Clerk of the National Assembly that he would not be making any submission on the Bill.

**ITEM 7: PRESENTATION BY THE GUYANA ASSOCIATION OF WOMEN LAWYERS INC.**

**7.1 Presentation:**

7.1.1 At 3.42 p.m. the Chairman welcomed Ms. Emily Dodson, Vice-President of the Guyana Association of Women Lawyers and invited her to proceed with her presentation.

7.1.2 Ms. Dodson described the composition of the Association and explained that the submission was the joint efforts of its members and proceeded to highlight the following issues as key concerns:

- Insufficient evidence being presented in court as a result of improper investigation by the Police.
- The proposed legislation could place further burden on the Court of Appeal.
- The need for provision in the legislation, to grant acquitted persons legal representation of their choice, as is the case in some jurisdictions.
- The denial of bail for acquitted individuals could impinge on their constitutional rights.
- Clause 34C(4) appeared to be unconstitutional, since there could be no offence after the acquittal of an individual.
- The need for sentencing guidelines to be established in order for the legislation to be effective.
- The absence of empirical evidence via research, to determine the need for such legislation.

7.1.3 At 3.56 p.m. Ms. Dodson concluded her presentation and the Chairman invited Members to proceed with their questions, observations and issues for clarification.

7.1.4 The following were some of the issues highlighted by Members of the PNCR-1G:

- The limit granted in Clause 34C(5) being taken away by 34C(6).
- Lack of public consultation to determine the need for such legislation.
- Lack of sentencing guidelines.
- Whether there was parity between constitutional rights and human rights guaranteed by Article 141 as it related to victims rights.

- Whether the Director of Public Prosecution's right to appeal was "*Ad nauseam*".
- Whether Jury trials should remain sacrosanct.
- Concern that if such power should be placed with the Director of Public Prosecution, integrity could be compromised.

7.1.5 Some of the issues highlighted by Members from the Government side were:

- Clause 34B(1)(a) clearly stated cases in which the Director of Public Prosecution had the right to appeal.
- Clauses 34H, 34J and 34K of the legislation made provision for an acquitted person to have legal representation. Was this the same as legal aid?

7.1.6 An interactive discussion ensued, allowing Ms. Dodson to provide relevant clarification that was sought by Members.

7.1.7 Thereafter, the Chairman expressed the Committee's appreciation to Ms. Dodson for a candid presentation of her organization's observations and concerns on the Bill.




