1. The Consumer Affairs Bill 2011 (No. 7 of 2011) which was published on 27<sup>th</sup> April, 2011 seeks to promote and protect consumer interests in relation to the supply of goods and services and for related purposes.

- 5.1.2 He advised that the Parliamentary Opposition had previously supported the Bill during its first and second readings on 28<sup>th</sup> April, 2011 and 19<sup>th</sup> May, 2011, respectively. However, a decision was taken to refer the Bill to a Special Select Committee, Therefore, in his view, he felt that it was mainly for procedural purposes that the Bill was now before the Committee.
- 5.1.3 He further informed the Committee that the Alliance for Change had declined to sit on the Committee due to the fact that the Bill already had their approval.
- 5.1.4 The Chairman then asked for suggestions regarding the methodology for the consideration of the Bill, that is, if Members saw the need for any amendments.

#### 5.2 Methodology

- 5.2.1 The Hon. Kellawan Lall opined that the Bill had previously gone through a consultative process, and therefore, there should be no need to seek further consultations. However, due to the absence of Members of the PNC/R, he suggested that consideration and adoption of the Bill should be deferred to a next meeting, at which it was anticipated that they would be present. The other Members of the Committee endorsed the suggestion.
- 5.2.2 Thereafter, the Clerk of the Committee advised on the available dates for the Committee to meet.
- 5.2.3 In light of the above, the Committee agreed to defer consideration of the Bill and schedule its next meeting for Monday, 13<sup>th</sup> June, 2011, at 10.00 a.m.

## ITEM 5: TO COMMENCE CONSIDERATION OF THE CONSUMER AFFAIRS BILL 2011 – BILL NO. 7 OF 2011.

#### 5.1 Preliminary Remarks

- The Chairman re-iterated to the Committee, the objective of the Bill and reminded Members that there was no prior contention to the Bill during its first and second readings. However, he wanted to ensure the Opposition's participation in the consideration process before it was submitted to the National Assembly for its third reading.
- He then invited members to share their views with regards to the content of the Bill.

#### 5.2 Consideration of the Bill

- Mr. Mervyn Williams stated that he had hoped to see reference being made to the public transportation sector and expressed concern with regard to the breaches in contract relating to the service provided. He was further concerned about the quality of goods entering the country and questioned the application of compliance with standards.
- Additionally, he suggested that the issue of hire purchase should have been addressed in the proposed legislation.
- 5.2.3 The Chairman acknowledged the concerns of Mr. Williams and advised that the issue of the transport service was an ongoing one that consumers had been lobbying for legislation for some time. He advised that the issue was being addressed.
- In response to the hire purchase query, the Chairman stated that he was aware of the problems faced by members of the public who were being ripped-off as a consequence of the lack of hire purchase legislation. He, however, advised that a new legislation was presently being drafted for introduction to the National Assembly and that this legislation would have widespread consultation.
- The Hon. Minister Webster advised Mr. Williams that his concerns could be addressed through the Competition and Fair Trading Commission which was set up to examine certain aspects of fair trading.

Thereafter, the Members of the Committee adopted the Consumer Affairs Bill 2011 (Bill No. 7/2011) without any amendments and agreed that a report of the Committee's deliberations would be prepared and submitted to the National Assembly at its next Sitting.

#### 5.3 Adoption of Draft Report .

- 5.3.1 The Committee examined the Draft Report of the Consumer Affairs Bill 2011 (Bill No. 7 of 2011). The Report was then adopted without corrections.
- 5.3.2 Thereafter, the Clerk of the Committee was requested to finalise the Report and Motion for submission to the National Assembly at its next sitting.
- The Chairman then thanked members and staff for their support and co-operation on the consideration of the Bill.
