UNIVERSITY OF GUYANA (AMENDMENT) BILL 1993

1. This Act, which amends the University of Guyana Act, may be cited as the University of Guyana (Amendment) Act 1993.

2. Section 12 of the Principal Act is hereby amended in the following respects —

(a) by the deletion of subsection (2) and the substitution of the following subsection therefor —

“(2) The Council shall consist of —

- (a) the Chancellor, the Pro-Chancellor, the Principal and Vice-Chancellor, the Deputy Vice-Chancellor, the Deans of Faculties, the Director of the Institute of Adult and Continuing Education and the Librarian by virtue of their office;
- (b) one person to be nominated by the Guild of Graduates;
- (c) one person to be nominated by the Students' Society;
- (d) one representative from the Ministry of Education and Cultural Development and one from the Ministry of Finance;
- (e) one person to be nominated by the political party in office and one by the Minority Leader;
- (f) one person to be nominated by each of the following:—
 - (i) the Adult Education Association;
 - (ii) the Consultative Association of Guyanese Industry Ltd;
 - (iii) the Women's Affairs Bureau;

- (iv) the Georgetown Chamber of Commerce and Industry;
 - (v) the Guyana Manufacturers' Association Ltd.;
 - (vi) the Guyana Trades Union Congress.
 - (vii) the Federation of Independent Trade Unions in Guyana;
 - (viii) the Guyana Rice Producers Association;
 - (ix) such body as in the opinion of the Minister appears to represent the interests of Amerindians;
- (g) four persons to be appointed by the Minister;
 - (h) one person to be nominated by the University of Guyana from each of the following —
 - (i) the Association of Universities and Colleges of Canada;
 - (ii) the American Association of State Colleges and Universities;
 - (iii) the Committee for International Cooperation in Higher Education.”;
 - (b) in subsection (3), by the substitution for the words “(b), (c) or (d)” of the words “(b), (c), (d), (e), (f), (g) or (h)”;
 - (c) in subsection (7), by the substitution for the words “(b), (c) and (d)” of the words “(b), (c), (d), (e), (f), (g) and (h)”.

EXPLANATORY MEMORANDUM

This Bill seeks to amend section 12 of the University of Guyana Act, Cap. 39:02, to enlarge the membership of the University Council to give increased representation to private and non-governmental organisations on the Council.
