2. REGION #3 RESPONSE TO COVID-19

Member Asking: Mr. Ganesh Mahipaul, M.P.

Can the Hon. Minister provide a detailed Report with reference to the Region's response to COVID-19 and the functions of the Regional Task Force on COVID-19?

ANSWER

"Prior to August 2nd, 2020, there were no provisions for Personal Protective Equipment (PPE) neither were there any provisions to provide relief to our Frontline Workers and by extension, the citizens of Guyana. The Region's response to COVID-19 has been comprehensive and served to stop the virus from getting out of control by providing PPE's as well as humanitarian and financial relief through COVID-19 Cash Grants to residents, including Hon. Ganesh Mahipaul. This is a stark contrast to the period of APNU/AFC when no support was provided to citizens, rather billions of dollars were mismanaged during the construction of the Liliendaal Facility and on the procurement of drugs and medical supplies.

The Regional COVID-19 Task Force functions were formed in keeping with the parameters of the newly constituted National COVID-19 Task Force. Prior to August 2020, the National and Regional Task Force bodies were politically directed by the APNU/AFC to disastrous consequences. During this period, there was minimal testing, lack of proper patient care and lack of drugs and medical supplies and financial mismanagement".

- (6) In the event of a suspect being shot and killed under unclear circumstances and/or questionable circumstances, what are the Standing Operational Procedures that relate to the immediate investigation into the conduct of the ranks involved in the incident?
- (7) Could the Minister explain why in the presence of an official Guyana Police Force vehicle was the suspect placed in a civilian vehicle after his arrest?

Clause 2

Mr. David Patterson, M.P., and seconded by Mr. Haimraj Rajkumar, M.P., moved the following amendments which were <u>put</u> and <u>negatived</u>:

Insert Subsection 2(A) -

"Nothing in this section shall prevent the Minister from obtaining written consent from any landowner or lawful occupier of any land described in subsection (1) (b) in any instance where a licensee and a landowner or lawful occupier fails reasonably to reach agreement on a consent from the landowner or lawful occupier and the Minister is reasonably satisfied that there is no commercially reasonable alternative available to the licensee.

In obtaining such consent from a private landowner of lawful occupier, the Minister shall determine adequate compensation payable for any damage to the surface of the lands or cultivation, and compensation for any commercial loss which may be suffered by the landowner or lawful occupier, arising from the licensee's exercise of its rights.

In the determination of adequate compensation, the Minister shall seek advice from the Government Valuation Division as well as at least one private Valuator.

Any such determination shall not deprive the landowner or lawful occupier of the right to legal recourse to the Courts".

<u>Clause 2</u> was then <u>passed</u> as <u>printed</u>.

AND WHEREAS a motion was brought by the Opposition Chief Whip Gail Teixeira, M.P., calling on the "National Assembly to adopt the report and its findings" and calling "on the Government to take measures to implement the recommendations therein in order to ensure that the democratic architecture of the state is preserved and strengthened";

AND WHEREAS the motion was debated in the National Assembly on August 4, 2016, and amended by the Government to read "the National Assembly acknowledges the report" and "calls on the Government to take measures to examine the findings and recommendations therein in order to ascertain whether any, and if so which, are acceptable and implementable;"

AND WHEREAS there was no movement on this Resolution by the former Government,

BE IT RESOLVED:

That this National Assembly adopts Volume 1 of the Report and its findings;

BE IT ALSO RESOLVED:

That the National Assembly calls on the Government to take measures to implement the recommendations therein in order to preserve and strengthen the

democratic architecture of the state; and

BE IT FURTHER RESOLVED:

That this National Assembly calls on the Government to take measures to cause the complete report emanating from the Commission of Inquiry be made public and publicly available electronically.
