structures thereon used or intended to be used for the purpose of a racecourse for racing
with horses and other incidental activities; and"."

<u>Clause 2</u> was then <u>passed</u> as <u>amended</u>.

<u>Clauses 3 and 4</u> were <u>passed</u> as <u>printed</u>.

Clause 5

The Minister of Culture, Youth & Sports moved the following amendments which were <u>put</u> and carried:

Clause 5 is amended by inserting immediately after paragraph (e) the following-

- "(f) approve the date for race meetings;
- (g) establish, maintain and publish the stud book of Guyana; and
- (h) appoint, discipline, and revoke the appointment of racing officials.".

Clause 5 was then passed as amended.

<u>Clauses 6 to 10</u> were <u>passed</u> as <u>printed</u>.

Clause 11

The Minister of Culture, Youth & Sports moved the following amendments which were <u>put</u> and <u>carried</u>:

Clause 11 is amended by inserting immediately after paragraph (c) the following-

- "(d) any fees collected in respect of the sale of publications and related material; and
 - (e) penalties levied in respect of any breach of the rules and regulations of racing.".

Clause 11 was then passed as amended.

Clause 12 was passed as printed.

Clause 13

The Minister of Culture, Youth & Sports moved the following amendment which was <u>put</u> and carried:

Clause 13 is amended by substituting for subclause (1) the following-

Cap. 73:02

"(1) The Authority shall, prior to the commencement of each financial year, prepare and submit its annual budget for consideration and approval in accordance with section 79 of the Fiscal Management and Accountability Act.".

Clause 13 was then passed as amended.

Clause 14 was passed as printed.

Clause 15

The Minister of Culture, Youth & Sports moved the following amendments which were <u>put</u> and carried:

Clause 15 is amended as follows-

"(2) The Authority shall not later than four months after the end of each Cap. 73:02 financial year submit an annual report to the Minister in accordance with section 80 of the Fiscal Management and Accountability Act.";

ITEM 2 - INTERNATIONAL MEASURES FOR THE PROTECTION OF CHILDREN (HAGUE CONVENTION) BILL 2024 – Bill No. 15/2024 published on 2024-11-21
