Notice is hereby given that —

- (1) under the applicable provisions of articles 102, 103, and 107 of the Constitution and all other powers enabling him in that behalf, the President has —
 - (i) with effect from 1989—01—01 appointed Cde. Jeffrey Thomas, M.P., Senior Minister, and Cde. Gowkarran C. Sharma, A.A., J.P., M.P., Minister, as members of the Cabinet;
 - (ii) with effect from 1989—01—01 appointed Cde. Stella Odie-Ali, M.P., and Dr. Faith Harding, M.P., formerly Ministers of State, as Ministers;
 - (iii) with effect from 1989—01—01 appointed Cde. Jean M.G. Persico, A.A., M.P., formerly Parliamentary Secretary, as a Minister.
 - (iv) partially modified, with effect from 1989—01—01 the assignments of responsibilities for the business of the Government among Vice-Presidents and other Ministers and their styles, and has made further modifications in such assignments —
