

ORDER IN COUNCIL UNDER THE DISTRICT LANDS PARTITION AND RE-ALLOTMENT ORDINANCE, CHAPTER 169, IN RELATION TO A PART OF THE WESTERN HALF OF PLANTATION FYRISH OR LOT NO. 3, SITUATE ON THE CORENTYNE COAST IN THE COUNTY OF BERBICE, IN FYRISH COUNTRY DISTRICT.

WHEREAS by the District Lands Partition and Re-allotment Ordinance, Chapter 169, provision is made for the partition and re-allotment of lands as therein enacted ;

And whereas by section 4 (1) of the said Ordinance it is provided that the Governor in Council, upon consideration of a petition presented in pursuance of section 3 of the said Ordinance, may, if he thinks fit make an order that the lands specified in such petition should be subject to the provisions of the said Ordinance ;

And whereas by section 4 (2) of the said Ordinance the Governor in Council may by order revoke any order so made ;

And whereas by section 5 (a) of the said Ordinance the Governor in Council is empowered to appoint a person to be the officer to partition and/or re-allot the said land, and by paragraph (b) of the said section may cancel any appointment so made ;

And whereas a petition dated the 31st day of January, 1936, was presented to the Governor in Council by the owners of a part of the western half of Plantation Fyrish or Lot No. 3 situate on the Corentyne Coast in the county of Berbice and Colony of British Guiana, and bounded as follows :—

On the North by the southern boundary of building lots Nos. 1, 2, 3, 4, 5, 6, 7, 8 and 17 ; on the South by the northern boundary of provision lot No. 1 ; on the East by the common boundary between the East and the West halves of Plantation Fyrish and part of the western boundary of the land belonging to the Missionary Society ; and on the West by the eastern edge of the trench which runs on the eastern side of and parallel to the western side line dam of Plantation Fyrish ;

And whereas the Governor in the exercise of the powers by the above recited Ordinance in him vested by and with the advice of the Executive Council made an order on 26th June, 1937, that the lands specified in the said petition should be subject to the provisions of the said Ordinance, and appointed Henry Ormonde Durham, Esquire, Sworn Land Surveyor, to be the officer to partition and/or re-allot the said lands ;

And whereas it has since appeared to the Governor in Council that it is not expedient that the said lands should be subject to the Ordinance :

Now therefore, the Governor, in the exercise of the powers by the above recited Ordinance in him vested, by and with the advice of the Executive Council—

- (1) doth hereby order that the abovementioned order of 26th June, 1937, be revoked ; and
- (2) doth hereby cancel the appointment of Henry Ormonde Durham, as aforesaid.
