PROCLAMATION

WHEREAS it is provided by section 4(2) of the Roads Ordinance, Chapter 277, that the President may, by Proclamation published in the Gazette, order that any road or any part of any such road mentioned in the schedule to the said Ordinance shall cease to be maintained out of moneys provided by the National Assembly and thereupon the provisions of the said Ordinance shall no longer apply to that road or any part thereof as the case may be;

AND WHEREAS it is expedient that the parts of the roads specified in the schedule hereto shall not be maintained out of moneys provided by the National Assembly;

NOW, THEREFORE, by virtue of the power in me vested by section 4(2) of the Roads Ordinance, Chapter 277, and of all other powers thereunto enabling me, I do hereby order that the parts of the roads specified in the schedule hereto shall cease to be maintained out of moneys provided by the National Assembly.

SCHEDULE**DEMERARA**

East Bank Demerara River
Parts of Main Road

The part of the main road at Plantation Eccles, East Bank of the Demerara River, commencing from a point near Station 110 + 00 and extending for a distance of 0.189 miles to a point near Station 120 + 00, as shown shaded yellow on Plan No. RS117/6 on deposit in the offices of the District Engineer, Atkinson Field, East Bank Demerara and of the Roads Division Ministry of Works, Hydraulics and Supply, Georgetown.

2. The part of the main road commencing at Plantation Providence, East Bank of the Demerara River, commencing from a point near Station 146 + 00 and extending for a distance of 0.227 mile to a point near Station 168 + 00, as

shown shaded yellow on Plan No. R.S. 117/8 on deposit in the offices of the District Engineer, Atkinson Field, East Bank Demerara and of the Roads Division Ministry of Works, Hydraulics and Supply, Georgetown.

BERBICE

West Coast

Parts of Main Road

The parts of the main road at Weldaad and Hope, West Coast of Berbice, commencing **firstly** from a point near Station 2514 + 00 and extending for a distance of 0.19 mile to a point near Station 2524 + 00, and **secondly** from a point near Station 2533 + 00 and extending for a distance of 0.15 mile to a point near Station 2541 + 00, as shown shaded yellow on Plan No. A.R.S. 295 on deposit in the offices of the District Engineer, Fort Wellington, West Coast Berbice and of the Roads Division, Ministry of Works, Hydraulics and Supply, Georgetown.

2. The part of the main road at Kingelly/Brahan, West Coast of Berbice, commencing from a point near Station 2725 + 00 and extending for a distance of 0.13257 mile to a point near Station 2732 + 00, as shown shaded yellow on Plan No. A.R.S. 295 on deposit in the offices of the District Engineer, Fort Wellington, West Coast Berbice and of the Roads Division, Ministry of Works, Hydraulics and Supply, Georgetown.

3. The parts of the main road at Cotton Tree, West Coast of Berbice, commencing **firstly** from a point near Station 3414 + 00 and extending for a distance of 0.15 mile to a point near Station 3422 + 00 and **secondly** from a point near Station 3424 + 00 and extending for a distance of 0.36 mile to a point near Station 3443 + 00, as shown shaded yellow on Plan No. A.R.S. 295 on deposit in the offices of the District Engineer, Fort Wellington, West Coast Berbice and of the Roads Division, Ministry of Works, Hydraulics and Supply, Georgetown.

4. The parts of the main road at Armadale and Bel Air, West Coast of Berbice, commencing **firstly** from a point near Station 2959 + 00 and extending for a distance of 0.0378 mile to a point near Station 2961 + 00 and **secondly** from a point near Station 2962 + 00 and extending for a distance of 0.0757 mile to a point near Station 2966 + 00, as shown shaded yellow on Plan No. A.R.S. 295 on deposit in the offices of the District Engineer, Fort Wellington, West Coast Berbice and of the Roads Division, Ministry of Works, Hydraulics and Supply, Georgetown.

5. The part of the main road at Golden Grove/Bush Lot, West Coast of Berbice, commencing from a point near Station 2919 + 00 and extending for a distance of 0.1136 mile to a point near Station 2925 + 00, as shown shaded yellow on Plan No. A.R.S. 295 on deposit in the offices of the District Engineer, Fort Wellington, West Coast Berbice and of the Roads Division, Ministry of Works, Hydraulics and Supply, Georgetown.

6. The part of the main road at Expectation or No. 9 West Coast of Berbice, commencing from a point near Station 3237 + 00 and extending for a distance of 0.15 mile to a point near Station 3245 + 00, as shown shaded yellow on Plan No. A.R.S. 295 on deposit in the offices of the District Engineer, Fort Wellington, West Coast Berbice and of the Roads Division, Ministry of Works, Hydraulics and Supply, Georgetown.

**East and Corentyne Coast
Part of Main Road**

The part of the main road at Palmyra/Prospect, commencing from a point near Station 188 + 15 and extending for a distance of 0.11 mile to a point near Station 194 + 10, as shown shaded yellow on Plan A.R.S. 411 on deposit in the offices of the District Engineer, Canje Berbice and of the Roads Division, Ministry of Works, Hydraulics and Supply, Georgetown.
