WHEREAS under subsection (2) of section 72 of the Summary Jurisdiction (Offences) Ordinance it is provided that, when owing to the number of offences under subsection (1) of the aforementioned section committed in any part of the Colony it appears expedient to the Governor in Council so to do, he may by proclamation published in the Gazette declare that part of the Colony a proclaimed district within the meaning of the aforementioned section:

AND WHEREAS owing to the number of offences under subsection (1) of section 72 of the aforementioned Ordinance committed in the parts of the Colony hereinafter described it appears expedient to the Governor in Council that those parts be declared proclaimed districts:

NOW, THEREFORE, by virtue of the authority conferred on the Governor by the said recited section, I do by this Proclamation declare the following parts of the Colony to be proclaimed districts within the meaning of subsection (1) of the said section, that is to say—

- (a) the East Demerara Judicial District;
- (b) the Georgetown Judicial District;
- (c) the North Western Judicial District; and

(d) those portions of the Berbice, West Demerara and Essequibo Judicial Districts situate north of imaginary straight lines between the Epira Mission on the Courantyne River and the confluence of the Puruni and Mazaruni Rivers and between that confluence and the confluence of the Akarabisi and Cuyuni Rivers.

WHEREAS under subsection (2) of section 72 of the Summary Jurisdiction (Offences) Ordinance it is provided that, when owing to the number of offences under subsection (1) of the aforementioned section committed in any part of the Colony it appears expedient to the Governor in Council so to do, he

AND WHEREAS, by a Proclamation dated the 7th July, 1942, certain parts of the Colony, including a specified part of the Berbice Judicial District, were declared to be proclaimed districts within the meaning of the above recited section:

AND WHEREAS, by Order in Council made on the 10th August, 1943, the Berbice Judicial District was (*inter alia*) sub-divided into the Berbice Judicial District and the Courantyne Judicial District:

AND WHEREAS it appears necessary to the Governor in Council that the part of the Colony now known as the Courantyne Judicial District shall continue to be a proclaimed district within the meaning of the above recited section:

NOW, THEREFORE, by virtue of the authority conferred on the Governor by the said recited section, I do by this Proclamation declare the Courantyne Judicial District to be a proclaimed district within the meaning of subsection (1) of section 72 of the Summary Jurisdiction (Offences) Ordinance.

MINING DISTRICTS (SUNDAY TRADING).

ORDER IN COUNCIL

made under section 191 (3) on the 20th January, 1925.

The Governor in Council has directed that the following portions of the undermentioned Mining Districts shall be "districts" under section 191 (3) of the Summary Jurisdiction (Offences) Ordinance—

All that portion of No. 1 Mining District lying within 10 miles of any claim held under a licence to mine for gold or precious stones issued under the Mining Ordinance or regulations for the time being in force.

All that portion of No. 2 Mining District lying within 10 miles of any claim held under a licence to mine for gold or precious stones issued under the Mining Ordinance or regulations for the time being in force.

All that portion of No. 3 Mining District lying within 10 miles of any claim held under a licence to mine for gold or precious stones issued under the Mining Ordinance or regulations for the time being in force.

All that portion of No. 4 Mining District lying within 10 miles of any claim held under a licence to mine for gold or precious stones issued under the Mining Ordinance or regulations for the time being in force.

All that portion of No. 5 Mining District lying within 10 miles of any claim held under a licence to mine for gold or precious stones issued under the Mining Ordinance or regulations for the time being in force.
