GUYANA

REGULATIONS

Made Under

THE EDUCATION ORDINANCE,

(Chapter 91)

UNDER SECTION 53 OF THE EDUCATION ORDINANCE THE FOLLOWING REGULATIONS HAVE BEEN MADE BY THE MINISTER TO WHOM RESPONSIBILITY FOR EDUCATION IS FOR THE TIME BEING ASSIGNED:-

1. These Regulations may be cited as the Guyana Scholarships (Amendment) Regulations, 1967, and shall be construed and read as one with the British Guiana Scholarships Regulations, 1965*, hereinafter referred to as the Principal Regulations and any Regulations amending the same.

2. The Principal Regulations are hereby amended by the substitution of the word "Guyana" for the words "British Guiana" wherever they occur.

3. Regulation 3 of the Principal Regulation is hereby amended—

- (a) by the renumbering of the regulation as paragraph (1);
- (b) by the deletion of the word "Three" at the beginning of the renumbered paragraph and by the insertion before the word "scholarships" of the words "Subject to the provisions of the next following paragraph, three"; and
- (c) by the addition thereto of the following paragraph as paragraph (2)—

"(2) Additional scholarships for both boys and girls may, subject to the provisions of paragraph (4) of regulation 7, be awarded upon the basis of the aforesaid examination."

4. Regulation 4 of the Principal Regulations is hereby amended—

- (a) by the insertion of the words "or five" immediately after the word "four" in paragraph (1); and

(b) by the substitution for paragraph (2) of the following paragraph—

“(2) Scholarships for courses of study of—

(a) three years duration shall each be of the value of \$11,664;

(b) four years duration shall each be of the value of \$15,480;

(c) five years duration shall each be of the value of \$19,296;

(d) six years duration shall each be of the value of \$23,112.”

5. Regulation 7 of the Principal Regulations is hereby amended—

(a) by the renumbering of paragraphs (4) and (5) as paragraphs (5) and (6) respectively;

(b) by the insertion of the following paragraph as paragraph (4)—

“(4) The award of any additional scholarship under the provisions of paragraph (2) of regulation 3 shall only be made where no preference in order of merit can be given to any of the candidates who has attained such a standard of performance as in the opinion of the Minister qualifies the candidate for award;” and

(c) by the substitution of the symbol “(5)” for the symbol “(4)” in the renumbered paragraph (6).

6. (1) Subject to the provisions of the next following paragraph, any scholarship awarded under the Principal Regulations, and being held at the commencement of these Regulations shall continue to be held as if it had been awarded under the Principal Regulations as amended by these Regulations.

(2) Any person who at the commencement of these Regulations is pursuing a course of study by virtue of a scholarship awarded under the provisions of the Principal Regulations shall be entitled to receive over the remaining period of the scholarship such annual payment as is commensurate with the value of the scholarship as provided by these Regulations.
