- (d) paragraph (b) of sub-regulation (1) of regulation 11;
- (e) paragraph (b) of sub-regulation (1) of regulation 12;
- (f) paragraph (b) of sub-regulation (1) of regulation 15;
- (g) paragraph (b) of sub-regulation (1) of regulation 18;
- (h) paragraph (b) of sub-regulation (3) of regulation 18; and
- (i) paragraph (b) of sub-regulation (1) of regulation 19,—

of the Principal Regulations.

10. Regulation 27 of the Principal Regulations is hereby revoked, and the following substituted therefor—

27. The poll shall be taken between the hours "Hours of voting. of seven in the morning and five in the afternoon."
