THE RICE (REGULATION OF MANUFACTURING AND MARKETING)  
ACT 1985

(No. 1 of 1985)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS  
52 and 90 OF THE RICE (REGULATION OF MANUFACTURING  
AND MARKETING) ACT 1985, I HEREBY MAKE THE FOLLOWING  
REGULATIONS :—

1. These Regulations may be cited as the Rice (Regulation <sup>Citation.</sup>  
of Manufacturing and Marketing) (Licence for Export) Regula-  
tions 1986.7

2. Every application for the grant of a licence to carry <sup>Application</sup>  
on the business of export of padi or rice or any other product <sup>for licence.</sup>  
of padi shall be made to the General Manager of the Board in <sup>Schedule</sup>  
Form A set out in the Schedule.

3.(1) A licence granted by the Board to carry on the <sup>Grant of</sup>  
business of export of padi or rice or any other product of padi <sup>licence.</sup>  
shall be in Form B set out in the Schedule. <sup>Schedule</sup>

(2) The licence shall be granted to the applicant on the  
payment by him of a licence fee of one hundred dollars.

(3) The licence shall be subject to the conditions speci-  
fied therein and to such other conditions as may be prescribed  
by the Minister by regulations or specified, from time to time,  
by the Board.

2. It may be revoked by the Board if the licensee fails to comply with any of the conditions subject to which the licence was granted.
3. Subject to paragraph 2, it shall remain in force until 31st December of the year in which it was issued.
4. The licensee shall comply with the criteria required for approving specific export transactions as published in the Gazette dated 25th January, 1986.
5. The licensee shall pay such current fees for each export transaction as are specified by the Board.
