A.D. 1968. Enacted by the Parliament of Guyana:—

Short Title. 1. This Act may be cited as the Supplementary Appropriation (1965) Act, 1968.

Supplementary amount sanctioned for financial year 1965. Schedule. No. 11 of 1965. 2. The expenditure during the year ended on the thirty-first day of December, one thousand, nine hundred and sixty-five, to the amount of five million, four hundred and two thousand, five hundred and forty-eight dollars and twenty-five cents on certain services set forth in the schedule to this Act and not fully provided for by the Appropriation Ordinance, 1965, is hereby sanctioned.
