AN ORDINANCE to amend the Customs Ordinance.

Enacted by the Legislature of British Guiana:—

—A.D. 1958

1. This Ordinance may be cited as the Customs (Amendment) Ordinance, 1958, and shall be construed and read with the Customs Ordinance, hereinafter referred to as the Principal Ordinance, and any Ordinance amending the same.

2. In part I of the first schedule to the Customs Ordinance (which as amended from time to time specifies the rates of import duties on certain articles) for the rates of import duties specified therein on the articles set out in the schedule to this Ordinance there shall be substituted the respective rates of duty specified in the schedule to this Ordinance.

3. This Ordinance shall be deemed to have come into operation on the 6th December, 1957.
