AN ACT to provide for the issue from the Consolidated Fund of the sums necessary to meet the expenditure (not otherwise lawfully charged on the Consolidated Fund) of Guyana for the fiscal year ending 31st December, 2012, estimates whereof have been approved by the National Assembly, and for the appropriation of those sums for the specified purposes, in conformity with the Constitution.

1. This Act may be cited as the Supplementary Appropriation (No. 2 for 2012) Act 2012.

2. The issue from the Consolidated Fund of such sums, not exceeding in the aggregate the gross of two billion, five hundred and seventy million, eight hundred and ninety-eight thousand four hundred and nineteen dollars (\$2,570,898,419), necessary to meet the expenditure of Guyana for the fiscal year ending on 31st December, 2012, is hereby authorised in accordance with article 219 of the Constitution and sections 24 and 41 of the Fiscal Management and Accountability Act, 2003.
