#### **EXPLANATORY MEMORANDUM**

This Bill seeks to change the name of the Fire Service Act to the Fire and Rescue Service Act; it changes the name of the Fire Service to the Fire and Rescue Service.

The Bill makes similar changes in the Fire Prevention Act and in all subsidiary legislation.

Accordingly, all laws are to be read and construed in accordance with the changes of names effected by this Act.
