# SUPPLEMENTARY APPROPRIATION (NO. 2 FOR 2013) BILL 2014 ARRANGEMENT OF SECTIONS

A.D. 2013 Enacted by the Parliament of Guyana:-

Short title. 1. This Act may be cited as the Supplementary Appropriation (No. 2 for 2013) Act 2013.

The issue from the Consolidated Fund of such sums, not exceeding in the aggregate the gross of one billion four hundred and seventy-four million, nine hundred and sixty thousand four hundred and fifty-four dollars (\$1,474,960,454), necessary to meet the expenditure of Guyana for the fiscal year ending on 31 st December, 2013, is hereby authorised in accordance with article 219 of the Constitution and Sections 24 and 41 of the Fiscal Management and Accountability Act 2013.
