- (2) Every member of a constabulary has in relation to -
  - (a) any offence committed against this Act;
  - (b) any offence committed in any place vested in, or under the control of, the N.O.C. or in any public place in the council area,

all the powers and is entilled to all lhc privileges and immunities conferred on a police constable by any law for the time being in force.

(3) Where a constable iays an information or makes a complaint against any person in respect of any of ence against this Act, any member of a constabulary not below the rank of corporal and serving in the same constabulary as the aforesaid constable may appear before the magistrate exercising jurisdiction in the matter and has the same powers and privileges as to addressing the magistrate and examining the witnesses as the constable who laid the information or made the complaint would have had."

#### EXPLANATORY MEMORANDUM

The main thrust of chis Bill is to include the neighbourhood democratic council in the local government system for al I purposes.

The Bill makes some consequential amendments and increases penalties in a number of areas.

The Bill gives the Minister of Legal Affairs the power to prescribe by order fees payable for any process, including the process of P!1rate execution.
