AN ACT to amend the Intoxicating Liquor Licensing Act.

Short title.  
Cap. 82:21

1. This Act which amends the Intoxicating Liquor Licensing Act, may be cited as the Intoxicating Liquor Licensing (Amendment) Act 2016.

2. The provisions of the Principal Act specified in column one of the TABLE are amended in the manner specified in the corresponding entries in column two.


