**AN ACT** to amend the Miscellaneous Licences Act.

A.D.2016

Enacted by the Parliament of Guyana:-

Short title. 1. This Act, which amends the Miscellaneous Licences Act, may be cited as the Miscellaneous Licences (Amendment) Act 2016.

Amendment of the Principal Act. 2. The provisions of the Principal Act specified in column one of the Table are amended in the manner specified in the corresponding entries in column two.



SECTION	AMENDMENT
Section 10 (1)	(a) by substituting for the words “six dollars” the words “five thousand dollars”;  (b) by substituting for the words “one hundred and fifty dollars” the words “ten thousand dollars”.
Section 12	by substituting for the words “three hundred dollars” the words “ten thousand dollars”.
Section 17	(a) by substituting for the word “fifteen dollars” the words “ five thousand dollars”;  (b) by substituting for the words “one hundred and fifty dollars” the words “ten thousand dollars”.
Section 18 (2)	by substituting for the words “one hundred and fifty dollars” the words “five thousand dollars”.
Section 19 (2)	by substituting for the words “one hundred and fifty dollars” the words “ten thousand dollars”.
